I'm.....aware that the sport practiced in La Sorrera Bike Park, of Downhill and Enduro and other disciplines in bicycle, are potentially dangerous involving physical and material risks. I also understand that to practice this sport can occur accidents and cause me injuries of various considerations, as well as to third parties.

With this knowledge, I declare myself to be fully capable of practicing the sport of cycling in the modalities practiced within La Sorrera Bike Park and I declare myself aware of the risks involved in using the Bike Park facilities and services.

Therefore, I fully assume the responsibility of this use and declare to be responsible for the injuries (including death) that may inflict on me the use the Bike Park facilities, or that may cause third parties.

In another hand, I accept as my own the responsibility caused by material damages that may occur both in my own equipment (including all its elements), as in the third party or elements of the Bike Park facility.

I undertake to make responsible use of the facilities of La Sorrera Bike Park and to respect the indications, signs and the authorized personnel. I commit to use the appropriate material as well as the use of the mandatory helmet and the protections to protect me from possible injuries. I accept that failure to comply with the rules of use of the Bike Park facilities will mean the possible immediate expulsion of the Park.

The applicable regulations are at my disposal and can be consulted in the offices of Bike Park, as well as on the website too. The purchase of the ticket includes insurance according to what is established in Decree 56/2003 of physical sports activities in the nature.
