

MANIFEST

That I, an adult, am aware that the sport practiced in the Bike Park La Sorrera, downhill, enduro and other cycling disciplines, are potentially dangerous involving physical and material risks. I also understand that in practice accidents can happen that cause me injuries of various considerations, as well as to third parties. With this concern, I declare to be fully capable of practicing the sport of cycling in the modalities practiced within the facilities of the Bike Park of La Sorrera and I declare myself aware of the risks involved in the use of the facilities and services of the Bike Park. Therefore, I fully assume responsibility for this use and declare myself liable for any injuries that may be inflicted on me by the use of the Bike Park facilities, or that may be caused to third parties. Likewise, I assume my own responsibility for material damage that may occur both in my own equipment (including all elements) and in third-party equipment and / or the elements of the Bike Park installation. I undertake to make responsible use of the facilities of the Bike Park La Sorrera and to respect the indications, both of the signs and of the authorized personnel of the facilities and I undertake to use the appropriate material as well as the use of the helmet mandatory and protections to protect me from possible injury.

I assume that non-compliance with the regulations for the use of the Bike Park facilities will result in possible expulsion immediately. The applicable regulations are at my disposal and can be consulted in the offices of the Bike Park, as well as on the website. The acquisition of the ticket or forfait, includes insurance in case of accidents in accordance with the provisions of Decree 56/2003 on physical sports activities in the environment, which will be valid as long as the regulations of the Bike Park (rules section) and is not under the influence of alcohol and / or narcotics.

IMAGE RIGHTS FOR LA SORRERA: The signatory expressly consents to LA SORRERA for obtaining, reproducing and publishing his own image in order to produce news or reports within the communication programs of the Bike Park . This consent is granted without limits of acts of communication and for an unlimited period of time. La Sorrera is not obliged to broadcast, in whole or in part, the resulting images. This authorization assigns the image rights without any consideration in return. The content of this document will be valid for the use of the facilities of the Bike Park, the transfer of the image rights prior to the acquisition of the ski pass, indefinitely.
